

SERVICE WARRANTY 6 Months & Unlimited Hours

Komatsu Australia Pty Limited ABN 71 143 476 626 (Komatsu) warrants to You for six (6) months from the Service Date that any Service performed for You by Komatsu is free from Defects in material and workmanship, subject to the terms of this Warranty.

This Warranty covers all Service supplied by Komatsu to You, excluding those covered by our Standard Machine, Machine Extended Powertrain & New Parts warranties.

. Definitions

In this Warranty, the following definitions apply:

Business Hours means normal trading hours of Komatsu or Komatsu Service;

Consumables includes Ground Engaging Tools, fuels, oils, lubricants, coolants, batteries, filters and other items customarily regarded as consumables in the industry;

Defect or **defective** means any Service which does not comply with OEM specifications, or which is not rendered with due care and skill; **Komatsu** means Komatsu Australia Pty Ltd;

Komatsu Service means Komatsu's nominated servicing establishment;

Machine means the Komatsu equipment upon which the Service are performed and where the context so requires, may include non-Komatsu equipment upon which Service are performed;

Maintenance Program means the program, specified by the OEM and/ or Komatsu, that details the processes, methods and Your responsibilities for Machine or Parts maintenance and includes the Manuals provided with the Machine;

Manuals means any operation, service or other manual or instruction or recommendation or other information supplied to You by the OEM or Komatsu in relation to the Machine;

Non-Komatsu Attachments means an attachment to or supplied with the Machine which is not manufactured by Komatsu or any member of the Komatsu group of companies;

OEM means the manufacturer of the Machine or attachment (as the context requires);

Part means the parts provided to You by Komatsu in connection with the Service excluding those parts covered by Komatsu Machine Extended Powertrain and New Parts warranties or covered by any OEM warranty for Non-Komatsu attachments and excludes Consumables:

Required Documents includes all documents relevant to the Machine including without limitation, Warranty registration documents, proof of purchase documents, commissioning documents and maintenance records;

Service means any service or repair of specified equipment supplied under a Komatsu service invoice.

Service Date means the earlier of either: (A) the date of Komatsu invoice for the Service; or (B) the date on which Komatsu notifies You that the Service is complete or it deems them complete;

Warranty means this document;

Warranty Period means six (6) months from the Service Date;

You means the person or business who initially purchased the Machine from Komatsu and Your has a corresponding meaning.

2. Warranty as to materials and workmanship

- 2.1 Komatsu warrants that all Service supplied to You by Komatsu will be free from Defect in the workmanship of Komatsu or Komatsu Service subject to these terms and conditions for the Warranty Period.
- 2.2 In the event that any of the Service is found to be defective in either materials or workmanship during the Warranty Period, Komatsu shall at its cost and at its option:
 - (a) resupply the Service (which may include in Komatsu's sole discretion, repairing or replacing any service items rendered unusable by the defective Service such as coolants and oils); or
 - (b) pay the cost of resupply of any defective Service;
 - in accordance with this Warranty, subject to these terms and conditions.

3. Service to be provided by Komatsu

- (a) Any Service to which You are entitled under this Warranty shall be provided to You by Komatsu or Komatsu Service during Business Hours.
- (b) If Your claim is approved under this Warranty, then reasonable travel and transportation costs for our service personnel between Your site and Komatsu Service will be paid by Komatsu.
- (c) Transportation, repair or replacement costs for any Machine or Part or attachment or Consumable and any transport costs for any repaired or replacement Machine or Part whether to or from (as Komatsu directs) Komatsu or Komatsu Service for the purposes of any Warranty claim are at Your expense unless Komatsu advises You otherwise in writing and subject always to the terms of any other applicable Komatsu warranty.

4. How a claim is made and evaluated- 'Your Responsibilities'

- (a) All claims and associated enquiries by You under this Warranty must be notified in writing to Komatsu or to the nearest Komatsu Service.
- (b) Komatsu has no obligation under this Warranty unless You notify Komatsu of any Warranty claim promptly and no later than seven (7) days from becoming aware of any potential claim and allow Komatsu reasonable access to the Machine or Part the subject of the Warranty claim in order to evaluate the claim.
- (c) In order to lodge a valid claim under this Warranty, You must:
 - (a) provide Komatsu with a purchase order stating 'Subject to Warranty' and specifying the details of the warranty claim;
 - (b) provide evidence to Komatsu that the Service were provided by Komatsu or Komatsu Service and is under Warranty as at the claim date;
 - (c) provide all other Required Documents to Komatsu;
 - (d) pay for or provide all non-warranted labour and bear all non-warranted labour costs; pay for any non-warranted shipping charges if any; pay for any non-warranted travel costs if any and pay the non-warranted transport costs if any, associated with moving the Machine or Part to Komatsu Service;
 - (e) pay the costs of making the claim and the costs incurred if any, to investigate any claim found not to be a covered by this Warranty.

Failure to comply with any of these requirements may invalidate or reduce your warranty entitlements.

5. Termination of the Warranty

- This Warranty ceases at the end of the Warranty Period. (a)
- (b) If Komatsu resupplies any Service, then such Service is warranted for the balance of the Warranty Period. If Komatsu pays for the resupply of any Service by any non-Komatsu entity, then the applicable warranty offered by that entity shall apply.

Application of this Warrantv 6

- This Warranty applies only to Service supplied within Australia for Machines used within Australia within the Warranty Period. (a)
- This Warranty is conditional upon the Machine being maintained by You in accord with the Maintenance Program. (b)
 - This Warranty does not apply:

 - if You breach or do not comply with any of Your Responsibilities in item 4. above or otherwise; if any Defect is caused or contributed to by Your misuse, negligence, accident, or failure to maintain or use the Machine or the Part in accordance with the Maintenance Program or the recommendations of Komatsu or the OEM; if any Defect arises as a result of or in connection with, a condition identified through the Maintenance Program or (b)
 - (c) otherwise, for which Komatsu has recommended certain action to You and You fail to comply with that recommendation; in relation to alterations, modifications or repairs to a Machine or Part, including the fitting of attachments, parts or use of
 - (d) consumables, that are not authorised or approved by Komatsu and which in Komatsu's reasonable judgment, cause or contribute to the Defect;
 - to repairs or replacements required due to normal maintenance or operating service for the Machines or Parts, including but not limited to inspections, adjustments, tune-ups, fuel, lubricants, or Consumables, parts repairs or replacements; if You have delayed more than seven (7) days in notifying of any potential Defect after first becoming aware of it; if You have unreasonably delayed in providing the Machine or Part to Komatsu after first becoming aware of it; (e)

 - (g) (h) if You fail to adhere to any recommendation made by Komatsu;
 - if You fail to supply the Required Documents when requested by Komatsu; or
 - if Komatsu in its sole discretion determines any use or installation of the Machine or Part has caused or contributed to the Defect.

Limitation of Warranty 7

- To the extent permitted by law, this Warranty is exclusive and is in lieu of all other express or implied warranties, conditions and representations of merchantability or fitness for any particular purpose, whether statutory or otherwise.
- Without limiting the generality of clause 7.1, no warranty is given and Komatsu disclaims and excludes all express and implied warranties, conditions and representations in respect of:
 - (a) service other than Service provided by Komatsu or Komatsu Service: or
 - Defects or defects caused or contributed to, or arising as a result of, or in connection with, any service which are not supplied by either the OEM or Komatsu or Komatsu Service, or for and on behalf of Komatsu, provided that nothing (b) shall limit the warranties provided to You independently by any supplier of such service.
- 7.3 The liability of Komatsu to You for loss, damage, injury or property damage, whether direct or indirect, special or consequential or otherwise, arising out of breach of this Warranty, shall be limited to requiring Komatsu to comply with clause 2.2.
- 7.4 Komatsu shall not be liable to You or to any other third parties in contract, tort or equity, for breach of any statute (to the fullest extent permitted by law) or in any other action, including but not limited to:
 - direct or indirect loss of profit or revenue, loss of use of any Machine, Part, part, component, or associated equipment, (a) cost of capital, cost of substituted equipment, facilities or service, downtime costs, labour costs in connection with or arising out of the supply, performance or use of the Machine or any Part or any Service or service performed by Komatsu: or
 - (b) any direct or indirect losses or special or consequential loss or damage or otherwise of any kind whatsoever,

arising directly or indirectly from any act, omission, breach, error, default, or delay of Komatsu or its employees or representatives in connection with, or arising out of, the supply, performance or use of the Service in the performance of, or in

- Nothing herein shall limit those provisions of any statutes, rules or regulations from time to time in force which imply or guarantee certain conditions or warranties or impose obligations on Komatsu which conditions, warranties and obligations cannot, or cannot except to a limited to de the believe the excluded, restricted or modified. If any such statutory provisions apply, then to the extent to which 75 Komatsu is entitled to do so, its liability under those statutory provisions shall be limited at its option to: (a)
- in the case of goods: i. the replacement of goods or the supply of equivalent goods; or ii. the payment of the cost of replacing the goods or of acquiring equivalent goods; or iii. the payment of the cost of having the goods repaired; or

 - the repair of the goods; and iv
 - in the case of service. (b)
- the supply of the service again; or the payment of the cost of having the service supplied again. ii.

8. Assignment or Transfer Subject to Condition

You shall not assign or transfer any of Your rights or obligations under this Warranty unless in accord with Komatsu's then current Warranty transfer procedure.

Governing Law 9

This Warranty is governed by the laws of New Zealand.
